### **Ordinary Resolutions**

Ordinary Resolution 1: To reappoint the Auditors for 2024 - Crowe Clark Whitehill **Result: Resolution Passed** 

Ordinary Resolution 2: To approve the membership subscription rates for 2023 **Result: Resolution Passed** 

### Changes to the Rules of the British Orthopaedic Association

Ordinary Resolution 3: Change the Rules to allow any Voting Member to stand for election as a Trustee. **Result: Resolution Passed** 

Ordinary Resolution 4:*Providing Ordinary Resolution 3 passes.* Change the Rules to allow a Voting Member, who has previously been elected to the Board of Trustees and completed one full term of office, to stand for election as President. **Result: Resolution Passed** 

Ordinary Resolution 5: Change the Rules so that the President is elected by the Voting Members. **Result: Resolution Passed** 

Ordinary Resolution 6: *Providing Ordinary Resolution 3 passes.* Change the Rules to allow a Voting Member, who has previously been elected to the Board of Trustees and completed one full term of office, to stand for election as Honorary Treasurer. **Result: Resolution Passed** 

Ordinary Resolution 7: Change the Rules so that the Honorary Treasurer is elected by the Voting Members.

**Result: Resolution Passed** 

Ordinary Resolution 8: *Providing Ordinary Resolution 3 passes.* 

Change the Rules to allow a Voting Member, who has previously been elected to the Board of Trustees and completed one full term of office, to stand for election as Honorary Secretary. **Result: Resolution Passed** 

Ordinary Resolution 9: Change the Rules to amend the election process for Honorary Secretary from first past the post to single transferable vote.

Ordinary Resolution 10: Remove specific dates for elections from the Rules to allow flexibility for voting to take place later in the year and align with Congress. Nomination and voting periods will still be open for four weeks.

Ordinary Resolution 11: To stipulate that Home Members and SAS Members must be resident and in practice in the British Isles (to reflect the same arrangements for Home Fellows and Home Associates). **Result: Resolution Passed** 

Ordinary Resolution 12: Minor changes to terms to align terminology across the Rules. **Result: Resolution Passed** 

Ordinary Resolution 13: Minor changes to terms to clarify the 'membership year' **Resolution Passed** 

Ordinary Resolution 14: Change the term of office of the BOA Representative on the RCS England Council from 4 years to 2 years (the change has been approved by RCS England) **Result: Resolution Passed** 

# Changes to the Articles of Association of the British Orthopaedic Association

Special Resolution 1: Providing that Ordinary Resolution 3 passes.

Change Article 16.5 final paragraph to reflect that no person other than a Lay Trustee may be elected or appointed as a Trustee unless he or she is a Voting Member rather than a Home Fellow member.

**Special Resolution 2:** Change Article 22.1.3 to change terms of office for Committee members (to align with terms of office of other key appointments e.g. Trustee).
