Amplitude *pro one*[™] is the same platform but designed for use by individuals and small teams, giving you a detailed **'whole practice' view** of all your patients' outcomes regardless of location or funding.

What makes Amplitude unique is the vast amount of **pre-loaded clinical data** enabling users to easily add appropriate and accurate **case mix adjustment** and monitor the progress of your patients, picking up deviations from expected recovery and any post intervention complications.

Being web based, the system gives patients the freedom to complete scores online, anywhere and on any device, whilst the clinicians' dashboard gives clinicians the ability to quickly input treatment and patient specific data. **All data is retained locally** and available in near real-time for reporting and analysis.

Amplitude specialises in the collection of electronic PROMs and clinical outcomes and we are the leading supplier of electronic PROMs to the NHS. **We are accredited by NHS Digital** for the electronic capture and upload of National PROMs. Our platforms have achieved the highest levels of IG compliance and our data centres are ISO27001 certified.

All Amplitude run registries, National PROMs and NJR* data, collected within the system, is sent automatically to the relevant recipient meaning data is retained for local reporting and analysis whilst **compliance to registry submissions** is maintained.

Amplitude is the only system that **captures both National PROMs and NJR data** in the same platform, giving you direct linkage of this key data immediately as it is entered into the system.

Our systems are designed to support clinicians and add value, giving you easy access to analysis and self-monitoring tools. Both *pro one*[™] and *pro enterprise*[™] can be used to generate **revalidation reports**, quickly and easily, taking away the administrative drudgery of maintaining and producing these.

The system **automates the process** of data collection via a series of reminders sent to patients via email and SMS. These reminders are triggered from the intervention data which at minimum includes procedure/intervention description and diagnosis.
